

Younger Veterans Forum « YVF» Wednesday, 1 November 2023

Minutes

Agenda Item 1 Welcome, apologies and conflicts of interest

The Chair opened the meeting acknowledging country, veterans, current serving Australian Defence Force Personnel and families. The Chair introduced himself to members as the new Repatriation Commissioner and discussed his intentions for the role and forum.

The Chair **ACKNOWLEDGED** the resignation of Talissa Papamau from the Younger Veterans – Contemporary Needs Forum (YVF) and the contribution she provided and welcomed Lucinda Casey from the Partners of Veterans Association of Australia Inc as an observer.

No conflicts of interest were raised. Attendance and apologies are listed at Annexure A.

Agenda Item 2 Minutes & actions of previous meeting

Members **ENDORSED** the Minutes of the 19 July 2023 meeting.

Members **AGREED** to close action items Y2021/018, 2023YVF/A05, A06, A07, A09, A10, A11, A12, A13 and A15 and **NOTED** that action items 2023YVF/A04, A08 and A14 will remain in progress.

Agenda Item 3 Open Arms Model of Care

Members **NOTED** the update and the focus that is placed on goal setting and outcomes, as well as the importance of understanding the veteran experience from day one of service. Members **ACKNOWLEDGED** the impact of service on relationships and families. Members **DISCUSSED** the parameters of Open Arms and **NOTED** the reduction in its crisis accommodation service to ensure it is viewed as a transitional service and not as a longer term solution to managing homelessness.

Members **NOTED** the relationship with Defence and the impact of the increase in ADF personnel numbers by 2029-40 and the potential flow on effect for Open Arms. Members **DISCUSSED** the process of self-reporting to Open Arms for current serving members and if there is an imminent risk of self-harm, that would be reported to Defence. Members also discussed the current ratio of psychologists to social workers, with further discussion to occur at the next YVF meeting.

Agenda Item 4 Transition Update

The Chair introduced the item discussing his own transition experience and acknowledged the opportunity for YVF to contribute to work on transition. Members **NOTED** the Veteran Transition Strategy that was released on 22 August, which aims to align stakeholders, based on a shared vision, in order for a veteran and their family to transition well.

Members **NOTED** the update and **DISCUSSED** the range of pilot initiatives to assist in broadening ideas and possibilities for transitioning veterans in order to help make a difference. Members **ACKNOWLEDGED** that transition not only affects the veteran, but their partner and family as well.

Agenda Item 5 Wellbeing Framework Update

Members **NOTED** the update and the work across DVA and Defence and **DISCUSSED** seeking members' views on updates to the wellbeing factors that help underpin the whole of life wellbeing approach. Members **NOTED** that the framework was first introduced in 2020 and a review has commenced to ensure it aligns with Defence's wellbeing model and fills any gaps present. Members **DISCUSSED** the ecosystem that exists which requires support from many stakeholders, including ex-service organisations, providers and community members.

Members were updated on the work of the Commemorations Branch and **NOTED** the consultation process that will occur to develop a Commemorations Strategy for 2024 and beyond. Members **DISCUSSED** the targeted engagement with ex-service organisations to ensure a strategy is developed that accurately reflects the needs of the veteran community. Members **ACKNOWLEDGED** the request to provide feedback to Commemorations for this work to progress.

Agenda Item 7 Incorrect Data on DVA Web Site (The Warriors Return)

Members **NOTED** the priority for DVA to clear the claims backlog and how this will allow claims to be processed quicker, reducing the uncertainty and distress for veterans. Members **DISCUSSED** revised communication policies, including specific and clear commitments around timeframes of when DVA will contact clients to update on claims. Members **NOTED** the modernisation program to enhance MyService and to provide consistency and transparency on processing claims. DVA **ACKNOWLEDGED** the challenge when reporting an average for claims processing statistics and that the Department is still on track to clear the backlog by the end of 2023.

Members **NOTED** that DVA is working on the development of materials regarding tax treatment of payments from DVA and impacts for superannuation. Members **RECOMMENDED** an interdepartmental working group to consider the application of specific tax related legislation and how it pertains to veterans.

Member **DISCUSSED** the request of Partners of Veterans Association of Australia Inc to be included as a YVF member. Members **DISCUSSED** the need to ensure there is separation between the individual and the organisation they are representing and **NOTED** the need to ensure balance and diversity across the membership.

Members **ACKNOWLEDGED** the importance of defining what and who the forum is seeking to represent and to ensure membership is in the best position to reflect the views of the younger generation of veterans. Members **RECOMMENDED** that information be sought through the upcoming National Consultation Framework Review on the nature of the representation that contributes to YVF, to inform the development of a membership policy.

Members **AGREED** that any additions to YVF would need to be considered following the National Consultation Framework Review.
